To elucidate my Annual Financial Report 2016 of the European Section of the ICD, I would like to make the following comments:

Based on the decision that 40% of all the assets can be used for the Philip Dear Foundation (PDF), you will find the expenditures for the PDF only in the Liabilities of the Annual Report.

Profit and Loss Account 2016.

About the **Revenues:**

Despite the clear rules, a substantial part of the Annual Dues, to be collected by the Regents and to be transferred to the Treasurer were not paid in time. Per December 2016 \in 10.220 of the Annual Dues were still not paid. There was s slight increase of the total income from the fees paid by the Inductees, because there were more Inductees in Milan in comparison to the meeting in Dublin. These fees were all paid in due time.

What about the **Costs:**

The Regents Dinner in Dublin was not only for the Regents and Officers of the European Section, but was also attended by Officers and Guests of the International Council.

This year we have paid travel allowances for 5 (five) fellows to attend the International Meeting in the USA in supporting

- 1. Phillip Dowel as International President, who had in view of that function transferred his duty of Councilman to Mauro Labanca,
- 2. The International Editor Dov Sydney,
- 3. Argirios Pissiotis, Mauro Labanca and Frans Kroon as active Councilmen.

The per Capita fee for the International College was raised. The fee is now \$45 per Fellow.

Therefore, we see an increase of the Annual Dues tot he International Office.

Several Fellows from District 14 did not pay their Annual Dues for many years. Therefore \notin 3000 were declared to be non-collectable dues.

In 2016 the Section was victim of fraudelent banking practices by internet criminals for the sum of \notin 75.000. Until now only \notin 11.453 was refunded
